POOL RENTAL POLICY FOR PRIVATE PARTIES

Any member in good standing, who signs the attached agreement and abides by this policy, may rent the pool for private parties. The member signing this agreement (the Host) is responsible for the conduct of all guests and shall ensure that all rules and guidelines are followed.

Note: The City of Bellingham Noise Ordinance prohibits the use or operation of any device (e.g. stereo system) in such a manner as to cause a disturbance. The ordinance prohibits creating sound that is plainly audible at or beyond the property boundary, between the hours of 9PM and the following 7AM. The families who live near the pool have been reasonable in their tolerance of pool activities, and we work hard to maintain a good relationship with them. All members planning to use the pool for private parties also accept the responsibility of managing their party, so neighbors are not disturbed.

Members who are interested in scheduling a private party during the times allocated for such events must contact the Pool Manager. The Host must be on site during the entire time of the party and shall control who may or may not enter the pool grounds for their scheduled party. This individual shall meet with the lifeguard on duty prior to the start of the party to allow the guard to review any areas of concern.

The Host is responsible for cleanup, including bagging all trash and removing anything brought to the pool (e.g. extra tables, serving pieces, decorations, etc.). Consumption of alcohol on the premises is limited to adults only (21 years or older) and shall be under the direct supervision of the Host. All beverages and food must be in non-breakable containers. No glass is allowed within the pool grounds at any time.

Our goal is to be able to provide our members with an enjoyable experience. Please remember that all pool rules as well as COVID restrictions and guidance must remain in place during the duration of your event. Bayside Swimming Club and the Board of Directors shall not be responsible or liable for any personal injury, loss, or damage incurred during the event covered by this agreement.
